II. Moment of Silence Honoring Theo Cielos' Life and Work: One Year Remembrance

Sierra Rotakhina, Council Manager, said staff would set up a time later in the month to remember and celebrate Theo Cielos' life. Staff shared brief comments to remember Theo and <u>Co-Chair</u>

IV. Approval of October 26, 2023 Meeting Notes by Council

Co-Chair Batayola noted that the Council did not yet have quorum yet, so tabled this agenda item for a future meeting.

V. Public Comment

Council staff opened up the public comment period and read from a prepared statement.

Michelle Mood bought a home next to a mega warehouse in South Tacoma. The community is 42% white and the zip code has a number of health concerns, including the worst air pollution and shortest life expectancy. They are having difficulty working with the Tacoma City Council. They shared several requests of the Council to consider, including strengthening SEPA, having a health impact assessment completed, additional conditions for permitting, new laws to require air quality monitoring, and citizen oversight in overburdened areas.

Cathie Urwin lives in South Tacoma one mile east of a mega warehouse. They have been trying to fight the warehouse and are in a court case without legal representation. People in overburdened communities don't have legal resources or funds to fight city decisions or companies. They have well documented inequities in the community, but they are not being considered by city officials. They've asked for a health impact assessment, but the city will not conduct an assessment. They said the warehouse will contribute to an additional 10,000-12,000 vehicle trips a day.

Maria Fernandez, with the organization Ella in Yakima County, thanked Council staff for joining a community meeting in Mabton. ELLA has procured funding for water distribution events so residents can have drinking water. Maria said the new well is not producing enough water and has nitrates, so they are digging a second well. If it is not successful, the city doesn't have any options. These water issues have been going on for more than 60 years. They have appreciated EJC

guidance and are hoping they can count on the Council to recommend some funding for this important issue.

VII. Consider Adoption of Additional Climate Commitment Act & HEAL Act 2024 Budget Recommendation on Water Quality

<u>Co-Chair Batayola</u> introduced the agenda item and staff said that this budget proposal to address water quality issues was shared with the Council at the last meeting. She said Council Members weren't ready to adopt at the last meeting because the Tribal Representatives wanted more time to ensure there would not be unintended consequences to Tribal water rights. She said the current draft had edits to address those concerns. She reviewed the changes made to the proposal.

Motion: The Environmental Justice Council adopts the additional <u>2024 Supplemental Budget</u>

<u>Recommendation on drinking water quality</u> (see recommendation #15 on page 18) as presented with any amendments agreed to by the full Council on November 16, 2023.

The Council directs staff to work with Council Members (appointed and ex officio members), the Governor's Office, the Office of Financial Management, relevant agencies, and others as needed to continue to refine the budget estimates and other details while centering the intent of the recommendation adopted today.

The Council directs staff to submit the recommendation to the appropriate committees of the Legislature, the Governor, and the Office of Financial Management to inform the development of the 2024 state supplemental budgets.
