# HB 1541, the Nothing About Us Without Us Act

Todd Holloway, a member of the Community Collaborative's Disabilities and Access and Functional Needs Working group provided an update and answered questions about HB 1541, known as the "Nothing About Us Without Us" Act signed into law by Governor Inslee on March 26, 2024. This law requires inclusivity and representation for marginalized communities in policy and decision-making impacting them. Under this bill, task forces, work groups and advisory committees tackling issues affecting underrepresented populations must include at least 3 individuals with direct lived experience on that issue. The bill promotes engagement with a wider range of individuals within these communities, ensuring diverse voices are heard. Todd stressed that community participation is necessary to make sure this landmark legislation meets its promise and that agencies are held accountable for its implementation.

# Community Driven Outreach Initiative

The COVID-19 Community Driven Outreach Initiative partners with community organizations to improve COVID-19 information access and equity; develop meaningful and culturally appropriate and accessible communications; grow existing communications and engagement infrastructure; and strengthen relationships between communities and public health while addressing the social determinants of health amplified by the pandemic.

The panelists discussed the importance of understanding and addressing community needs during the COVID-19 pandemic, the challenges of pandemic fatigue, and the need for supporting and retaining community health workers. Comagine Health shared the results from a community survey they administered to almost 5,000 Washington


# COVID Insights Report and Community Chapbook

Amelia Bai and Mulki Mohamed, two Community Collaborative Thought Partners, shared a summary of two documents that were developed in partnership with community members. The COVID Insights document captures lessons learned about equity in public health during the COVID-19 pandemic and highlights recommendations for policy, institutions, and community. The Chapbook is a tool for remembering and reflecting on a challenging time for all—and how we, as a community, stepped up to the challenge. Both documents are scheduled to be released in May of 2024. The discussion provided the community a preview of what is in the documents and asked for input on how to distribute them so they reach a wide audience.
