Progress Among Testing Partners

- Strong movement towards integrated testing HIV, Syphilis, Chlamydia/Gonorrhea and HCV
- Solidifying Relationships with DOH-contacted Laboratories (PHL, PHSKC, CDD and MTL)
- Increased availability and use of point-of-care rapid test kits (HIV, HCV, Syphilis)
- Increasing comfort with data tools, e.g., Evaluation Web, HCV and Syphilis test kit reporting tools
- Increased collaboration between OID and testing partners (work meetings, trainings, technical assistance, show and tell of partner work, etc.)

In-Process Work

 Adding HCV testing – OID is a bit behind on providing HCV 101 and test kit. training, but coming to an office near you starting around the end of July and into early August

- Testing Quality Assurance plans (HIV, HCV, STI) are still due from many agencies – OID is happy to provide sample completed QA plans as well as set up time either virtually or in-person to help agencies develop these QA Plans. All QA Plans must be submitted by 8/30/2024 to prevent any pause in testing.
 - Includes firming up relationships with any prevention and/or care linkage. partners locally

In-Process Work

- Compliance running external controls routinely, documentation of testing conditions via logs (refrigerators, inventory storage areas, controls, etc.)
 - Remember, if you run rapid test kits, your office becomes LABORATORY
 - The Medical Test Site program has jurisdictions over labs in WA.
 - Not only is compliance required for MTS, but also to help ensure quality and equitable testing events throughout WA.

 - Legal requirements to report to LHJs
 - OID program reporting requirements

Special Note about HIV Reporting

- LHJ Reports Positive test results for rapid HIV, HCV and syphilis tests must be reported to the health department of where your client resides within <u>2</u> business days. Please see <u>HIV/AIDS | Washington State Department of</u> Health
 - HIV: check with your local LHJ to see if they have a locally-based case report form that they would like you to use, e.g., King County, Pierce County, etc., or if they would prefer the report to take a different form.
 - The statewide case report form may be used for other jurisdictions in WA, just make sure to send it to the appropriate local health department. See 150002-WAConfidentialHIVAIDSAdultCaseReport.pdf
- Preliminary Positive Reports (PPRs) applies to clients who have had a positive HIV test entered into Evaluation Web. Separate from an LHJ report, the testing agency must report client identifiers and test information to OID staff for the purpose of connecting the LHJ report with the test event entry in Evaluation Web. These reports can be made through Provide or through the Integrated Testing Consultant (JJ Baker). Please see Previde Provide Provi

Special Note about STI/HCV Reporting

- STI Reports all chlamydia, gonorrhea and syphilis positive test results are reportable to the health department where your client resides. These conditions are reportable within 3 business days. Please see Case Reports Washington State Department of Health for more information on where to report and to access the STI case report form
- Rapid Syphilis Testing Program Reporting reporting tool that tracks use of the DOH-funded syphilis rapid test kits and outcomes related directly to use of that kit. Spreadsheet format, monthly, aggregate, de-identified in nature. Also tracks false-positive rates with this test kit.
- HCV Reports HCV rapid positive test results are reportable to the LHJ of client's residence within two business days. For reporting guidance, please see Rapid Screening Testing Reporting Guidance | Washington State Department of Health. You can also reach out to OID Integrated Testing program staff with any questions. HCV case report forms (Chronic & Acute) can be found here: List of Notifiable Conditions | Washington State Department of Health
- Rapid HCV Testing Program Reporting reporting tool that tracks use of the DOHfunded HCV rapid test kits and outcomes related directly to that testing. Spreadsheet format, monthly, aggregate, de-identified in nature.

OID Testing Reporting Timelines

- Evaluation Web
 - Recommend data entry weekly
 - Due the 15th of the following month
- HCV Rapid Testing
 - Aggregate, de-identified monthly reporting
 - Due the 15th of the following month
- Syphilis Rapid Testing
 - Aggregate, de-identified monthly reporting
 - Due the 15th of the following month
- Preliminary Positive Reports (PPRs)
 - Weekly

Testing Supplies Ordering

- Point-of-Care Test Kits & External Controls
 - Syphilis
 - Syphilis Health Check (limited availability) ordered through vendor with dropshipping. OID requests 10 days advance notice of need from partners.
 - o HIV
 - Abbott Determine & INSTI regular 6-month cycle preferred, but can order as needed when need identified.
 - HCV
 - OraQuick generally ordered through McKesson with drop-shipping to testing partner. OID requests 10 days advance notice of need from partners.
- Note: controls will always come directly from the manufacturer or vendor via drop-shipping. Test kits may come either from the manufacturer/vendor or may be shipped directly from OID. OID is unable to store external controls for later shipping to partners

Condoms Supplies Ordering

Lifestyles

- Annual ordering cycle in March of each year
- Wide variety of condoms and lube available
- Between annual ordering cycles OID can fulfill need with Assorted Colors condoms. OID requests 10 days advance notice when ordering this item between annual ordering cycles.
- FC2 Internal/Female Condoms specialty, limited supply item offered periodically by OID. Watch your email for solicitation. Individual requests also considered.
- Other Items off contract condoms and lube (non-lifestyle products) may be of interest to test partners. Partners are welcome to purchase these on their own, and/or may be able to access DOH contract funds to acquire this item. Please consult with your DOH contract manager for more information.
