**Re: Informative- Health Equity Zone for Native Communities Selection**

Dear Honorable Tribal Leaders, Partners, and Professionals:

We are writing today to provide information about the Health Equity Zone for Native Communities selection.

This communication follows the guidelines of [Chapter 43.376 RCW](#), the [Washington State Centennial Accord of 1989](#), and the [DOH Consultation and Collaboration Procedure](#). We are informing you of the selection of the Health Equity Zone for Native Communities by the Indigenous Advisory Panel in October 2024. As we wrote to you on April 18, 2024, we invited Tribes, Tribal organizations, urban Native organizations, or a collaborative of these entities, to apply for the pilot phase of the Health Equity Zones Initiative.

The successful applicant is the Port Gamble S'Klallam Tribe, and the identified Health Equity Zone are the ancestral lands of the Port Gamble S'Klallam, spanning Kitsap, Clallam, Jefferson, Mason, and San Juan counties. Health Equity Zones is a pilot initiative, and we are hopeful that its success will lead to more zones and opportunities for Tribes and urban Native communities across Washington.
