# II. Moment of Silence Honoring Theo Cielos' Life and Work: Two Year Remembrance

Council Members and staff and those in attendance held a moment of silence in remembrance of former Council staff member, Theo Cielos. The Honorable Jarred-Michael Erickson, Interim Council Co-Chair, commented on the calming presence that Theo provided. Participants participated in creating a word cloud to uplift Theo's memory, which staff will share with Theo's family.

# III. Approval of Agenda by Council

Aurora Martin, Council Member, facilitated adoption of the <u>agenda</u>. **Motion:** The Council adopts the agenda. No objections noted. **The motion passed.** 

#### IV. Environmental Justice Conversation with Governor Inslee

<u>Co-Chair Batayola</u> welcomed Governor Jay Inslee to the meeting. Governor Inslee said he was at the United Nations Climate Change Conference and said it was nice to brag about the efforts of the EJ Council. He thanked Members for their work. <u>Running-Grass and Maria Blancas, Council</u> <u>Members</u>, commented on how authentic, community-centered engagement is the goal of environmental justice and they provided an update on the Council's community engagement work. <u>David Mendoza, Council Member</u>, shared updates on the Council's Climate Commitment Act responsibilities.

<u>Member Martin</u> asked Governor Inslee to share his most important accomplishment in advancing HEAL and environmental justice. He said they have been successful in investing in overburdened communities, adding that funds are being distributed in reasonable and fair ways. He said he appreciates the utility credits that went out for energy vouchers. He said they are doing air quality

work. He said that agencies are committed to HEAL. He commented on how voters rejected the Initiative to repeal the Climate Commitment Act, and said it needs to be protected moving forward. He commented on the tough budget outlook and said it's important not to use the CCA revenue to shore up the general fund. <u>The Honorable Jarred-Michael Erickson, Interim Council Co-Chair</u>, asked the Governor if he has had conversations with Governor-Elect Ferguson on how they want to move forward with the Climate Commitment Act. Governor Inslee said he has not had an opportunity to talk to Governor-Elect Ferguson about it, adding that he is confident he will keep the train on the tracks.

# V. Approval of October 24, 2024 Meeting Notes by Council

<u>Member Martin</u> facilitated adoption of the <u>October 24, 2024 meeting notes</u> (see page 9). **Motion:** The Council adopts the meeting notes for October 24, 2024.
No objections noted. **The motion passed.**

# VI. EJ Council Community Connection

Sierra Red Bow, Council Staff, introduced Edwin Hernandez, Executive Director with Duwamish Valley Sustainability Association, who shared a presentation that focused on a partnership with the Friends of Seattle to create and pilot a participation methodology for community outreach. <u>Member Running-Grass</u> asked about the funding they have received for the work. Edwin said they started in 2017 and have received funds from King County, the Port of Seattle, and the City of Seattle. <u>Member Martin</u> thanked Edwin for coming and congratulated him on their work to bring the principles of the HEAL Act to the local level. <u>Tatiana Brown, Council Member</u>, asked if there were community requests that the EJ Council can elevate. Edwin said they hoped more communities would use the methodology and receive the impact of the work.

# VII. Public Comment

<u>Debolina Banerjee, Senior Climate Policy Manager at Puget Sound Sage</u>, shared experience with Community Assemblies. Debolina said the Community Assemblies model gathers frontline

communities to learn about concerns and solutions to build resilience. Puget Sound Sage convened Assemblies to talk about issues in a culturally relevant way and to create a democratic open space to discuss topics, like Sound Transit.

<u>Luis Amado</u> echoed the comments that Edwin Hernandez shared earlier in the meeting and thanked Members for the time and support they gave to the community.

#### VIII. Discussion and Possible Adoption: Additional Budget Recommendations

<u>Council Co-Chair Erickson</u> said the Council had already adopted a set of budget recommendations and endorsed a number of agency decision packages. He said the Council would have an opportunity to discuss and possibly adopt two additional <u>budget recommendations</u> at today's meeting. <u>Christy Hoff, Council Staff</u>, reviewed the first budget recommendation about Community Assemblies. She said Council Members participated in four drop-in sessions to be briefed and ask questions.

**Motion:** The Environmental Justice Council adopts the Community Assemblies budget recommendation as presented on November 21, 2024 with any edits agreed to be the full Council. The Council directs staff to submit the budget recommendations to the appropriate committees of the Legislature, the Governor, and the Office of Financial Management to inform the development of the 2025-2027 biennial budget. The Council directs staff to work with Council Members, the Governor's Office, the Office of Financial Management, relevant agencies, and others as needed to continue to refine the budget estimates and other details while centering the intent of the recommendations adopted today.

Staff then briefed the Council on the EJ Fund proposal. Members discussed whether it was actually a policy proposal, rather than a budget recommendation. Members and Ex Officio Liaisons discussed the barriers to funding that currently exist in the system and how the solution requires a long-term systems change. <u>Co-Chair Batayola</u> said that collectively, we have identified a problem, but we do not know the solution. She said the next step is to convene a group of people to continue discussion with engagement from community.

# IX. Discussion and Possible Adoption: Legislative Session Procedure and 2025 Legislative Session Policy Statement

<u>Co-Chair Batayola</u> introduced the agenda item and Council staff provided a briefing on the proposed <u>legislative session procedure</u> (see page 23). Members discussed how the procedure would not need to be adopted each year but that they'd like to review it annually.
