## 3 Key Federal Budgeting Processes

**1. Reconciliation** – Tax and Spending Bill passed July 3, 2025

> Two more reconciliation packages possible in this Congress, as early as fall '25.

2. FY 26 Appropriations – current funding expires September 30, 2025

**3. Rescission Act of 2025** – primarily int'l health & aid (Congress has until July 18)

- Trump administration submitted a \$9.4 billion rescission package to Congress, seeking to claw back congressionally approved funds for fiscal year 2025.
- Democratic leaders threaten to shut down the government to stop to rescission package.

## Budget Reconciliation - Medicaid

#### Nationally

- >\$1 trillion in Medicaid cuts over 10 years
- ➢Significant changes in eligibility
- Implementation Dates: Jan. 1, 2027 or Jan. 1, 2029 with waiver

#### What This Means for Washington

- ≻Washington will lose at least \$3 billion per year in federal Medicaid funding.
- >At least **250,000 Washingtonians** (about 26% of current recipients) will lose coverage.
- ➢ 70- 90% of kids in Central Washington, Yakima, and Adams County on Medicaid.
- >Anticipate more than **doubling of the uninsured rate** (currently 4.8%).

### Budget Reconciliation - SNAP

#### Nationally

- > Approximately \$300 billion in cuts to SNAP
- Significant changes to eligibility, limits SNAP benefits to U.S. citizens, lawful permanent residents.

#### What This Means for Washington

- > 130,000 Washingtonians could lose their benefits as early as 2025.
- Every Washingtonian on SNAP will see benefits reduced under the Thrifty Food Plan by about \$56 per month.
- Reduces the federal cost share of SNAP administrative costs from 50% to 25% starting in fiscal 2027, increasing costs to the state of more than \$100 million at minimum.
- Less money for SNAP will result in decreased economic activity overall (grocery, farmers markets, etc.)

## Budget Reconciliation Silver Lining

#### **Rural Health Transformation Program**

- Senate version added rural health transformation program
- > \$50 billion over five years for eligible states
- Funds can be used to improve prevention and chronic disease management, technology-based solutions, paying providers for health care, recruiting and training rural health workforce, and other activities as designated by the Secretary.

## Federal Fiscal Appropriations

The Federal Government is currently funded through a Continuing Resolution that expires September 30, 2025.

#### **Key Appropriations Timeline**

- Spring and Summer 2025 Twelve Senate and House Appropriations committees consider the FY 26 request.
- August 2025 both chambers in recess. Significant in district meetings take place.
- September 30 current Continuing Resolution expires. House and Senate must have passed FY26 funding bills or the federal government shuts down.

## Washington's Accountable Communities of Health (ACHs)

- Established in 2015 as part of health system (and Medicaid) Transformation
- 9 entities
- Bring together healthcare, payers, social services, public health, and communities



### History of ACHs and DOH

2015 - Established as part of health transformation/State Innovation Model grant

2017 - Became part of Medicaid 1115 demonstration project (Medicaid Waiver 1) with focus on integration of physical and behavioral health and specific projects, including community-based care coordination (CBCC)

2020 to June 2025 - Significant investments from DOH COVID funding to get resources to communities for response and recovery

2023 - Community Care Hubs are a significant project in Medicaid Waiver 2.
