



Legislative Session Priorities.

- [ACLU of Washington](#) is pushing for state legislation to protect access to abortion and gender-affirming care, ending unlawful immigration practices, achieving health equity for immigrants, demanding police accountability, and defending fundamental rights.
- [Association of Washington Cities](#) will be prioritizing equitable housing, transportation, and criminal justice assistance funding during this legislative session.
- [Asian & Pacific Islander Coalition](#) legislative priorities include protecting immigrant and A&NH/PI communities, including funding for naturalization and legal services, worker protections, health coverage access, and broader equity initiatives.
- [Building Changes](#) priorities focus on keeping students safely housed, connected to school, and supported by systems that work. by developing community-driven strategies, advocating for systems change, and partnering across sectors to ensure children, youth, and families can thrive.
- [JUJustice Washington's](#) is focusing on advancing justice and equity across immigration and migrant worker protections, economic and food security policies, criminal justice reform, environmental and climate action, tribal sovereignty and representation, and inclusive civic legislation.
- [Northwest Bail Fund's](#) legislative priorities include ending harmful punitive systems, promoting alternatives to incarceration, and restoring civil rights for those impacted by the system.
- [The Community Advocacy Coalition for Developmental Disabilities](#) highlights the most urgent policy needs for people with intellectual and developmental disabilities in Washington
- [The Front and Centered Coalition](#) has compiled a list of legislative priorities related to food assistance, housing assistance, Medicaid/healthcare, and other social services.

- [Washington State Health Care Authority \(HCA\) Legislative Priorities](#) focus on keeping Washingtonians covered, responding to federal policy changes, and strengthening Medicaid, behavioral health, and public employee benefits programs.
- [Washington Youth Alliance](#) priorities include strengthening gun safety and mental health protections, funding equitably (including a wealth tax for schools), and defending budget support for rural education and youth mental health services.
- [Washington's Environmental Priorities Coalition](#) advocates for protecting climate and environmental health funding, restoring full wildfire resilience investments, advancing data center policies that safeguard communities and natural resources, and passing bottles and cans recycling programs.
